## UMAC POLICY ON SAFEGUARDING JUNIORS

In accordance with the Children (NI) Order 1995, a child is defined as a young person under the age of 18 years. Therefore, in the best interest of the child/young person, UMAC junior members or visitors must be accompanied by an appropriate adult with written consent of the child/young person's parent/guardian/carer.

The young person must always be supervised by the adult with responsibility for them, ensuring they do not place themselves or anyone else at risk of significant harm. Members are reminded that young members under the age of 14 years shall not start an engine or carry a model with the engine running without parental consent and the identified appropriate adult present.
